Variant I - proportional benefits system

In variant I (proportional benefits system) the Insurer pays the following types of benefits:

- 1) in the event of death resulting from an accident, if it occurs within 2 years from its occurrence – 100% of the sum insured,
- 2) for permanent health impairment:
 - a) in the event of 100% health impairment – the full sum insured specified in the agreement;
 - b) in the case of partial impairment – a percent of the sum insured corresponding to the percent of permanent health impairment.

Territorial scope clause:

Notwithstanding the remaining terms of the insurance contract unchanged by the clause below, regardless of the selected territorial scope, we do not provide insurance cover in countries or areas subject to sanctions or in which an armed conflict is currently taking place. Notwithstanding the above, we do not cover damage caused directly or indirectly as a result of hostilities, martial law, state of emergency, riots, riots, social unrest, strikes, lockouts, sabotage.
